Oct. 10. The health program will also offer blood pressure screening and counselling by Public Health nurses from the Visiting Nurse and Health Services Agency. A health education program on breast self-examination will also be offered by Nancy Sullivan, health educator with the Visiting

Nurse and Health Services. Hemmocult test kits will also be available to test for occult blood in the gastro-intestinal tract. This is a simple at home procedure, which tests for the presence of fecal blood. Test packets and dietary restrictions will be given out at the Health Fair. Attendees are asked not to take these tests unless they plan to use them and return the results to the office as they are very expensive

The Westfield Board of Health invites residents to participate in the health program being offered. Further information may be obtained by contacting the Health Department at the Municipal Building.
